### *Observer Reports*

#### THE ELECTION COMMISSION

The Election Commission, chaired by David Mofenson, continues to meet on a quarterly basis. (March, June, September, December). Kenneth Hartford joined the Commission in September 2005, as one of the two Republicans, replacing Steven Smith who resigned due to a conflict of interest.

The meetings are usually short and to the point. Peter Karg reports on upcoming elections, perennial problems with getting good election workers, and results of recent elections. He and his deputy, Dede Forgione, have streamlined the required forms and have instituted a number of changes to simplify record keeping for Wardens and Clerks.

The Election Commission also is in charge of the annual City Census, receiving returns and tabulating the results. In order to comply with the Mayoral request to cut all city department budgets by 5%, the Election Commission will no longer prepay postage for the return of the City Census. It remains to be seen if there will be a difference in the rate of return of the Census.

Most election workers are now trained in the new machines. The "check-out table", which was new to Newton when the new machines were instituted, is required by the state for communities using these machines. It has been a source of irritation for voters (and because 2 extra workers are required, a cost not incurred before). There is a bill pending in the Legislature to do away with the check-out table, also to allow for non-residents and some qualified high-school students to be Election Workers.

The challenge in the next election will be training for the new electronic machines for both the visually and hearing-impaired. There will be one machine in every voting site (even if there are two precincts in one physical place). As of the last meeting, March 14, 2006, the state had not chosen the vendors for these new machines, but it was ascertained that there will be a paper trail.

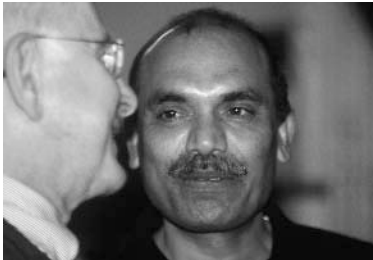

## PARKS AND RECREATION COMMISSION REPORT

*This report covers items discussed at the December 2005, January, February and March Commission meetings, and a Crystal Lake neighborhood meeting held in early April, 2006.*

### Strategic Planning for Parks

A "Park Assessment and Development Plan & Evaluation" was completed on Jan 1, 2006 and was used to set priorities for Community Preservation Act proposals. The Commission submitted a joint \$107,100 proposal for "strategic design funding" for the Newton Highlands Playground (including the Whitmore Tot Lot) and the Newton Upper Falls Playground, which were its two top priorities. The Community Preservation Committee held a hearing in early March, and a working session on April 4.

### Status of CPA Proposals

Many 2004 and 2005 CPA projects co-sponsored by Parks and Rec have completed the approval process and are now underway: Washington Park design plan; Gath Pool improvements; City Hall landscaping; Newton Centre Playground design plan; Newton Senior Center Park; Farlow-Chaffin Preservation design plan; Bowen Playfield/Park.

A \$753,700 proposal for Stearns-Pellegrini Park, the \$32,000 Albemarle Central Corridor Design Plan, and the Cheesecake Brook Greenway Concept Plan for \$24,000 are pending before the Board of Aldermen, as of mid-April. The Cheesecake Brook proposal would link a DPW project (already underway with Community Development Block Grant funds) to the Albemarle/Russell Halloran complex and then north to the Charles River Pathway. DPW Commissioner Bob Rooney supports it and would implement construction if the funds are approved.

### CPA Applications for 2006

June 1 is the deadline for any proposals or ideas that require co-sponsorship of the Parks and Recreation Commission, to allow staff to review them and the Commission to avoid a logjam at its September meeting.

### NSHS Synthetic Turf Proposal

In December, the Commission was asked informally whether it would approve a proposal to put synthetic turf on the baseball diamond and other land under the jurisdiction of the Commission which is adjacent to School Department property. The commission was not sympathetic to the idea for a number of reasons. As of mid-April this proposal is still before the Community Preservation Committee.

### Crystal Lake

Crystal Lake will re-open for public use on June 12. In December, the regulations for Crystal Lake were amended to prohibit all-terrain vehicles (ATV's), snowmobiles or hovercraft (except for emergency vehicles) on or in the water of Crystal Lake. Water skis, jet skis, and other similar motorized vehicles are already banned. State authorities have pledged assistance in dealing with any future violations of these regulations. Efforts to repair the retaining wall between the public beach and the abutter at 20 Rogers St. rest with the Law Department. A management consultant was hired to help address the needs for sand, the wall, etc. A request for an Order of Conditions from the Conservation Commission and a joint waiver from the State regarding some alleged violations by the Commission have been approved.

Dear CPC Members:

The League of Women Voters of Newton remains concerned about many of the issues raised at the initial hearing of the artificial turf proposal. As we have heard and considered discussions unfolding in the community, we are further questioning the wisdom and appropriateness of using CPA money to fund rebuilding of these fields.

We question the proposed large commitment of CPA funds for this type of project. The NSHS fields are important to community athletics and need maintenance. A capital project to restructure the fields may be wise for the city to undertake as it plans ahead for several years of NNHS construction that will take those fields out of play. However, although a tenuous legal argument may be made to justify this as a CPA project on the basis of 'expanding recreational opportunity,' we do not believe this project meets the intent of the CPA law.

We also question the priority status implied by dedicating such a large share of the fund to this project. The CPC's obligation under the statute is to recommend funds according to a community-wide needs assessment. Can we honestly say that this project represents a need commensurate with our insufficient affordable housing, acquisition/protection of open space, and protection of deteriorating historic properties?

Further, attending to water issues is of paramount importance. South Meadow Brook, which runs under the fields, regularly floods downstream areas. Flooding is an immense potential liability for the city and could ultimately cost more than this proposal. Therefore, flood control should be coordinated with the Conservation Commission and with other projects in this watershed area.

We also fear that a strong advocacy campaign may lead to hasty approval of this project. Using this material in this location, requires vetting thoroughly and realistically of both first and long term maintenance and replacement costs. \*

We urge you to proceed with the utmost scrutiny as you assess this large request for CPA funds and thank you for your thorough and thoughtful deliberations.

*\*(<http://www.brooklinegreenspace.org/PDF/Artificial%20Turf.pdf>), research by the Brookline Green Space Alliance, indicates that artificial turf is not without maintenance costs. For example, it can become overheated and need to be watered before team play. It also does not allow for decomposition of spilled bodily fluids or trash.*

Dr. Nemzoff was a pioneer in developing programs for persons with disabilities and started the equal opportunity office in the New Hampshire State Department of Education. In addition, she was a consultant to schools on gender equity.

She is currently the chair of the advisory committee of the University of Massachusetts Center for Women and Politics, as well as a member of LWVN.

Dr. Nemzoff holds a Doctorate in Administration, Planning, and Social Policy from Harvard University, a Master's degree in Counseling from Columbia University, and a Bachelor's degree in American Studies from Barnard College. ■

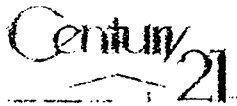

Carol Stapleton of the P&R Department, and Officer David Schaeffer of the Police Department addressed efforts to deal with these issues. The NHNAC is forming a Crystal Lake Task Force.
